CONTRACT

The Harold Himmel Velde collection consists of six groups of material: subject files, photographs, scrapbooks, bound volumes, audio-visual items, and memorabilia. Each group is described individually in the finding aid. The majority of the collection dates from 1943 through 1956.

The subject files (f.1-f.215), largest of the six divisions, contain material accumulated by Velde, his congressional staff, and members of his family. Subject matter is varied, but much of the collection pertains to Velde's chairmanship of the House Un-American Activities Committee, 1953-54. Other subjects include campaigns, public statements, personal and family papers, clippings, and the Federal Bureau of Investigation. The case files of the Velde and Prettyman law firm (f.183-f.202) dealing with the collection of delinquent accounts are restricted. The subject files are arranged alphabetically by subject.

The photograph section (f.216-f.233) consists primarily of photographs of Velde's years in Congress. The section is arranged chronologically. Undated photographs are divided into subjects.

The scrapbooks division consists of twelve volumes of clippings, apparently compiled by Velde's congressional staff, pertaining to Velde's years as a Congressman.

There are six books in the bound volume section concerning miscellaneous topics.

The audio-visual section consists of two non-professional, family films and fifteen record albums. Labels indicate the following subjects: interviews with Velde, campaign spots, and miscellany. * a professionally made film titled "A Day With Your Congressman"

The memorabilia section consists of nine items.

The fragmentary nature of the Velde collection resulted from extensive weeding prior to the time it reached The Center. According to the donor, high school students discarded all moldy and damaged documents several years before transfer to the repository.
